Development of model of local intervention (policy recommendation, financial instruments of reference, schemes for call for proposals) to be suggested to regional authorities for adoption within the framework of the implementation plan 4. Availability of materials, models and schemes to the regional authorities (to share experiences, to adopt them, to integrate existing running experiences and policies/call for proposals within the framework of 2014-2020 Programmes and development plans) 5. Identification of supporting services to be provided at local level by BIOs to support the implementation of the above mentioned policies (digital economy) 6. Development of toolkit of instruments and services to support BIOs to assist SMEs/economic operators to be involved for the implementation of the above considered policies 7.
